AND WILL BE BILLED ACCORDINGLY. I UNDERSTAND THAT IT IS MY RESPONSIBILITY TO CONTACT THE CITY OF DUNN WATER DEPARTMENT FOR DISCONNECTION OF SERVICE. IF I RENT/LEASE THE PROPERTY AND FAIL TO DISCONNECT SERVICE, I WILL BE HELD RESPONSIBLE FOR THE ACCOUNT BALANCE AND ALL SERVICES PROVIDED TO THE RESIDENCE BY THE CITY UNTIL SUCH TIME THE SERVICE IS CONNECTED IN THE TENANT'S NAME. THESE SERVICES INCLUDE WATER, SEWER, GARBAGE, RECYCLING AND STORMWATER FEE FOR THE PERIOD OF TIME THE TENANT HAS RESIDED AT THE RESIDENCE. IF THE CITY OF DUNN DETERMINES AN OCCUPANT IS LIVING AT THE RESIDENCE, SERVICE WILL BE IMMEDIATELY TERMINATED AND NO REFUND GIVEN.

THIS TEMPORARY SERVICE IS ONLY AVAILABLE FOR 30 DAYS FROM THE DATE OF CONNECTION.

IF YOU NEED SERVICE AFTER THIRTY (30) DAYS, YOU WILL NEED TO RENEW THIS TEMPORARY SERVICE BY PAYING AN ADDITIONAL \$35.00 PROCESSING FEE FOR THE NEXT THIRTY (30) DAYS. IF YOU SET UP SERVICE FOR MULTIPLE MONTHS AND DECIDE TO RENT/SELL/TERMINATE SERVICE COMPLETELY, NO REFUND WILL BE ISSUED.

CONSTRUCTION METERS WILL NOT BE DISCONNECTED UNTIL SUCH TIME THE CERTIFICATE OF USE AND OCCUPANCY IS ISSUED BY THE INSPECTIONS DEPARTMENT.
