## Terms & Conditions for Rental of the City of Dunn Park Baseball/Football Fields

Thank you for your interest in leasing a City of Dunn Park Baseball/Football Field(s). Please review the terms and conditions listed below. Once the information is complete, please return to the Parks & Recreation office located at 205 Jackson Road along with the rental fee of \$250.00 a field per day and \$20.00 per hour a field for lights or \$25.00/\$30.00 (lights) per hour with a max of 2 hours. Additional charges for field prep include \$50.00 daily per field, plus \$20.00 per field for additional same day prep. It is recommended you retain a copy of this page along with your receipt as proof of rental.

- City-owned park fields may be reserved for private events for \$250.00 per day per field with \$20.00 per hour in addition for lights per field. Additional charges for field prep include \$50.00 daily per field, plus \$20.00 per field for additional same day prep or \$25.00/\$30.00 per hour (max 2 hours). Hours of use must be specified when booking the event. Can only be booked in hour time slots.
- Events must be paid for in cash during the week before the event.
- The city shall not discriminate against users based on race, gender, color, creed, religion, national origin, or political affiliation, nor shall it rent to those who do.
- The Baseball/Football field(s) shall not be used for any unlawful or offensive purposes and all users must abide by local, state, and federal laws.
- Litter must not be left in or around the premises.
- No alcoholic beverages, smoking, or firearms are allowed on-premises.
- No loud music is allowed on the premises.
- No Parking allowed inside the park.
- Any city-owned equipment or other property destroyed, stolen, or abused while the shelter is leased to a user shall be replaced and/or repaired by the user.
- Any privately-owned equipment shall be brought in, set up, and then taken out by the user after the rental period and shall not be leftover or stored on the premises.
- Hours available for rental are daily from 8 a.m. until 8 p.m.
